"Less Lethal...But Still Lethal"

The use of light/sound distraction devices, more familiarly referred to as "flash-bangs" or "stun grenades", has become a common tactic in such "high-risk" entries. The device's job is to stun violent offenders momentarily, via a blinding flash of light and a violent explosion, giving tactical personnel an advantage during entry. There are several configurations of distraction devices, the most common of which is the grenade type device. This article addresses the use and misuse of that configuration, and is located in the Core Database under document #590273.

"Uniform and Plain Clothes Attire, Equipment and Appearance Policy"

This policy is from the West Palm Beach, Florida, Police Department Standard Operating Procedures Manual. The Department requires all members to be neat, well-groomed and professional in appearance and personal hygiene. The dress and equipment used by members of the Police Department will be properly maintained so that a positive image is projected.
