"Use of 10-Codes vs. Use of Plain Language in Radio Communications"

Over time, police agencies have customized their own agency-specific codes, resulting in several different meanings for codes among federal, state and local

agencies. The move to plain language has helped resolve this problem when more than one agency is responding. This IACP Fact Sheet is intended to help local agency decision-making by providing useful information, and can be found in the Core Database under document #588832.

"Requesting Federal Law Enforcement/National Guard Assistance"


